

Online User Guide for Annual General Meeting on 14 May 2025

The Annual General Meeting (the "AGM") of Hutchison Telecommunications Hong Kong Holdings Limited (the "Company") will be a hybrid meeting. In addition to physical attendance, shareholders of the Company (the "Shareholders") can attend, participate and vote at the AGM electronically through online access at https://meetings.computershare.com/HTHKH2025AGM (the "Online Platform").

The Online Platform will be open for registered Shareholders, non-registered Shareholders, as well as their proxies and corporate representatives to log in approximately 30 minutes prior to the commencement of the AGM (i.e. from 11:30 am on 14 May 2025) and can be accessed from any location with internet connection by a smart phone, tablet device or computer. Please refer to the Company's circular to Shareholders dated 3 April 2025 and notification letter to Shareholders dated 3 April 2025 (the "Notification Letter") for login details and arrangements. If Shareholders have any questions regarding the login details and AGM arrangements in general, please contact the Hong Kong Share Registrar of the Company, Computershare Hong Kong Investor Services Limited ("Computershare") at 17M Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong or call its hotline (852) 2862 8558.

Below are some pointers in relation to the use of the Online Platform. If Shareholders experience any technical difficulties or require assistance while using the Online Platform, please call Computershare at (852) 2862 8558 from 9:00 am to 1:00 pm (Hong Kong time) on the date of the AGM. Kindly note that the hotline cannot record your vote(s) over the telephone.

和記電訊香港控股有限公司(「本公司」)股東週年大會(「大會」)將以混合會議形式舉行。本公司股東(「股東」)除親臨出席大會外,亦可以電子方式透過網站 https://meetings.computershare.com/HTHKH2025AGM(「網上平台」)於線上出席、參與大會並於會上投票。

網上平台將於大會開始前約30分鐘(即由2025年5月14日上午11時30分起)開放予登記股東、非登記股東,以及其委任代表及公司代表,透過智能電話、平板裝置或電腦於任何有互聯網連線的地點登入。登入詳情及安排請參閱本公司日期為2025年4月3日致股東之通函及日期為2025年4月3日致股東之通知信函(「通知信函」)。股東如對登入詳情及大會整體安排有任何疑問,請聯絡本公司的香港股份過戶登記處香港中央證券登記有限公司(「中央證券」),地址為香港灣仔皇后大道東183號合和中心17M樓,或致電其電話熱線(852) 2862 8558。

以下為有關使用網上平台的若干指引。如股東於使用網上平台時遇到任何技術問題或需要協助,請於大會舉行當日上午9時至下午1時(香港時間)致電中央證券,電話號碼為(852) 2862 8558。請注意,該電話熱線無法在通話過程中記錄 閣下的投票。

Some pointers:

- 1. You will need a reliable internet connection that is fast and stable enough to support video streaming (for example, as if you are watching a YouTube video).
- However, unlike YouTube, if your internet connection is not fast or stable enough to support video streaming or keep pace with the AGM proceedings, part or parts of the AGM online broadcast may be lost or skipped. You will not receive the broadcast on a delayed basis and may miss part or parts of the AGM proceedings.
- If your internet connection is unstable or inadequate resulting in the video streaming of the AGM being interrupted, you may be unable to vote or raise questions. This will not affect the AGM itself which will continue and will remain valid and effective.
- 4. When your internet connection is restored, you might be able to rejoin the AGM online but you may have missed part or parts of the AGM proceedings (including the voting session) which will not be repeated. You may also need to login again using the login details sent to you.
- Each set of Shareholder login details can only be used on one device (for example, smart phone, tablet device or computer) at a time, and cannot be shared with others.
- 6. You are recommended to participate in the AGM via tablet device or computer for the best experience, and to test the compatibility of your device/web browser by logging in earlier prior to the commencement of the AGM.

The online AGM is technology-dependent and the above are some of the possible risks with respect to an online meeting. To ensure your right to vote is exercised, you might want to appoint the Chairman of the AGM as your proxy by returning a completed and signed proxy form no later than 48 hours before the time appointed for holding the AGM. Alternatively, you can choose to appoint another person as your proxy in accordance with the arrangements for proxy appointment in advance of the AGM as set out in the Company's circular dated 3 April 2025.

用戶指引:

- 閣下將需要可靠的互聯網連線,其速度及穩定性須可支援視頻串流(如同觀看YouTube影片一樣)。
- 但與YouTube不同,如 閣下的互聯網連線速度或穩定性不足以支援視頻串流或未能與大會過程保持同步, 閣下將可能接收不到或跳過網上大會部分直播內容,而直播內容將不會延遲播放,閣下可能因而錯過部分大會過程。
- 3. 如 閣下的互聯網連線不穩定或不足而令大會直播視頻串流被中斷, 閣下會因此無法投票或提出問題。這情況將不會影響大會本身的運作,大會將繼續進行並維持有效。
- 4. 當 閣下的互聯網連線回復正常, 閣下可重新參與網上大會, 惟可能已錯過部分大會過程(包括投票環節),而這些過程將 不會重覆。 閣下或需重新輸入發送予 閣下的大會登入資料以 便再次登入網上平台。
- 每組股東登入資料僅能在同一時間於一個裝置(如智能電話、 平板裝置或電腦)上使用,並且不能與他人共用。
- 6. 本公司建議 閣下使用平板裝置或電腦參與大會以獲得最佳體驗,並應在大會開始前提前登入,以測試 閣下的裝置/網絡瀏覽器與網上平台的兼容性。

網上大會需要科技配合,上述情況僅為部分有關網上會議的潛在 風險。為確保 閣下的投票權利得以行使, 閣下或擬於大會指定舉 行時間前不少於48小時內交回已填妥及簽署的代表委任表格,以便委 任大會主席為 閣下的委任代表。 閣下亦可選擇按照本公司於 2025年4月3日發出的通函所載,有關大會舉行前任命委任代表之安 排,委任他人為 閣下的委任代表。 Shareholders can login to the AGM Online Platform from 11:30 am (Hong Kong time) on Wednesday, 14 May 2025.

2. Then enter your shareholder number and PIN:

For registered Shareholders:

- Shareholder number: please use the 10-digit shareholder reference number starting with "C" ("SRN") printed under the barcode on the top right corner of the Notification Letter.
- PIN: please enter the five-digit Personal Identification Number (PIN) printed below the SRN.



<u>For non-registered Shareholders, proxies or</u> <u>corporate representatives of Shareholders:</u>

You will receive an invitation email with a meeting web link if you have provided your email address. Upon clicking the web link, you will be directed to the meeting page. Click "Join Meeting Now" and click "Sign In".

Alternatively, you can select "Invitation" and enter your invite code. The invite code can be found in the invitation email.


閣下可從屏幕右上方的按鈕「■」更改網上平台的顯示語言。



2. 然後輸入 閣下的股東編號及密碼:

登記股東:

- 股東編號:請使用列印於通知信函(英文版)右上角條碼下,以字母「C」開始之10位數字股東參考編號。
- **密碼**:請輸入列印於股東參考編號下方的五位數字個人識別號碼(PIN)。



如 閣下曾提供電郵地址, 閣下將收到一封電子邀請函,內有會議連結。點擊該會議連結後, 閣下將會被自動導向至大會頁面。點擊「立即參加大會」及「登人」。

或 閣下可選擇「邀請碼」並輸入邀請電郵內列明之邀請碼登入。





3. Once logged in, you will see the AGM Online Platform homepage which displays the webcast screen.

Click on "**Broadcast**" on the top of the screen to watch the broadcast

The broadcast will start automatically when the AGM commences.



4. When the poll is open, a list of all the resolutions and voting choices will be displayed. Please scroll through the list to view the resolutions.

You can enter your vote(s) as soon as the resolution(s) and voting options are displayed on the screen. To vote on a resolution, click on one of the voting options ("For" or "Against"). Your vote will be highlighted and confirmed.



3. 登入後, 閣下會看到大會網上平台主 百,顯示網上百播。


於屏幕上方點擊「廣播」。

直播將於大會開始時自動播放。




4. 投票表決開始時,畫面會顯示全部決議 案的列表及投票選項。請滾動列表以查 看決議案。

> 當決議案及投票選項於屏幕上顯示時, 閣下便可進行投票。請就每項決議案 點擊其中一個投票選項(「贊成」或「反 對」)以進行表決。 閣下的投票選項將 會被標示,並被確認。



5. To change your vote, click "Click here to change your vote" to override. The final option you click before the voting closes shall be your final vote for the resolutions concerned



6. If you would like to pose a question during the AGM, click on the "Q&A" tab on the top of the screen. You can type your question in the text box in English or Chinese (maximum 1000 characters) and then submit by clicking "Send".

Your submitted question will only be seen by the Company's representatives but not other attendees at the AGM.
